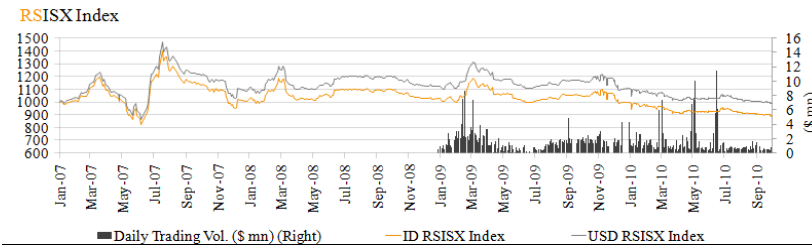

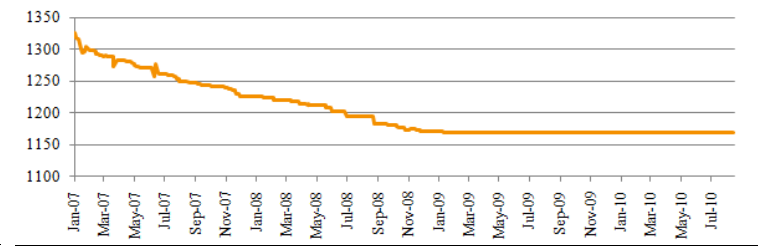
By the end of the week, 34 companies were able to trade in this session, and 30 companies were unable to do so mainly due to their General Assembly Meeting or ISX / ISC Instructions.

The dinar remained stable for the week, trading at 1170 to the dollar. Volumes for the week reached ID4.4 bln (\$3.7 mn), and the numbers of shares traded reached 3.2 bln, with the banking sector experiencing the highest volume and turnover.

Foreigners executed total 219 transactions this week. They executed 208 buying transactions amounted at ID671.8 mn (\$574.2ths) and 11 selling transactions amounted at ID42.8 mn (\$36.6ths). The total number of traded shares was 477.0 mn, and the total trading volume was ID714.7 mn (US\$610.8 ths).

News from Iraq

Politics

- Iraqi Prime Minister Nouri al-Maliki said his coalition is close to forming a government and could announce a new coalition by next week, ending the country's long-running political crisis. This is not going to be easily determined, but the progress of these talks indicates we have come to near the end of these negotiations, Maliki told The Christian Science Monitor on Friday.
- The Al-Iraqiya Alliance welcomes the initiative of Massoud Barzani, the president of the Iraqi Kurdistan region, to accelerate the process of forming the new Iraqi government, q spokesperson of the al-Iraqiya said on Friday.

Economics

- Iraq raised its estimate of national crude oil reserves to 143.1 bln bbl (24% increase), Oil Minister Hussain Al-Shahristani said on Oct. 4th, overtaking Iran as home to the world's fourth-largest petroleum deposits.
- The International Monetary Fund (IMF) has praised Iraq for making "good progress" in reconstructing its economy. It commended it for maintaining macroeconomic stability in the face of difficult security conditions. The IMF also gave the go-ahead for a \$741 mn (£469 mn) loan to Iraq.

ISX – Recent Company Announcements

- Iraqi Agricultural Products Marketing (AIRP) will start distributing 20% cash dividend of starting on October 17th, 2010.
- Iraqi Land Transport (SILT) announced that the General Assembly Meeting will be held on October 25th, 2010 to discuss annual accounting report of 2009, capital increase through 91.827% bonus issue and 53.324% rights issue. ISX will suspend trading of SILT shares starting on October 19th, 2010.
- AL-Badia General Trans (SBAG) will resume trading on Sunday, October 10th, 2010 after the completion of capital increase through 25% bonus issue from ID900 mn (\$769.2 ths) to ID1.125 bln (\$961.5 ths).
- Iraqi Middle East Investment Bank (BIME) announced that the General Assembly Meeting will be held on October 25th, 2010 to discuss annual accounting report of 2009 and capital increase through 51.515% rights issue. ISX suspended trading of BIME shares starting on October 8th, 2010.
- Al-Mansour Pharmaceuticals Ind. (IMAP) resumed trading on October 5th, 2010 after the completion of 15% capital increase through bonus issue. The paid-up capital of the company reached ID2.50 bln (\$2.14 mn) from ID2.17 bln (\$1.86 mn).
- Iraqi Islamic Bank (BIIB) resumed trading on October 4th, 2010. BIIB shares were not trading since August 8th, 2010 according to ISX decision for not supplying its 2009 final accounts.
- Modern Paint Industries (IMPI) resumed trading on October 3rd, 2010. IMPI shares were not trading due to General Assembly Meeting (GA).
- Al-Kheir Financial Investment (VKHF) resumed trading on October 3rd, 2010. VKHF shares were not trading since August 8th, 2010 according to ISX decision for not supplying its 2009 final accounts.
