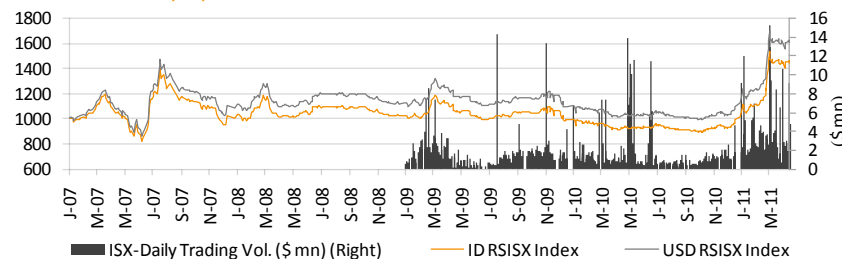

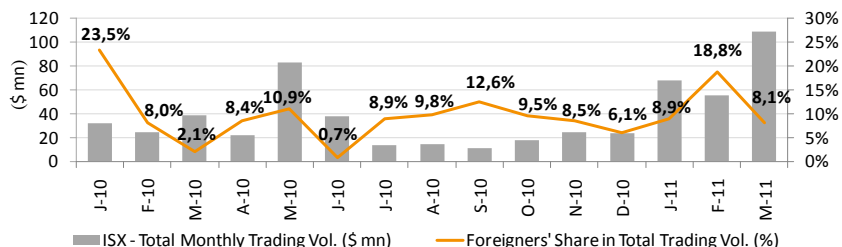

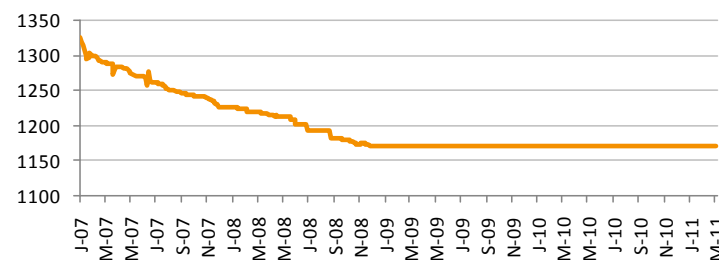
The dinar remained stable for the week, trading at 1170 to the dollar. Volumes for the week reached ID22.7bln (\$19.4mn), and the numbers of shares

traded reached 13.3bln, with the banking sector experiencing the highest volume and turnover.

Foreigners executed total 688 transactions this week. They executed 644 buying transactions amounted at ID8.0bln (\$6.8mn) and 44 selling transaction amounted at ID223mn (\$190ths). Thus, net purchases of foreigners reached ID7.8bln (\$6.6mn), while their share in total trading volume was 18.1%.

News from Iraq

Politics

- The Legislature of al-Iraqiya Bloc, Wihda al-Jumeily, has said on Thursday the existence of a Kurdish mediation, led by Kurdistan President, Masoud Barzani and Iraqi President, Jalal Talabani, to settle the suspended issues between the National Alliance and al-Iraqiya. (Aswat Al-Iraq)
- North Iraq's Ninewa Province's Council has voted on Tuesday on the rejection of extending U.S. troops presence in Iraq, after the end of their presence according to the Security Agreement concluded between Baghdad and Washington. (Aswat Al-Iraq)

Economics

- The Chairman of the Investment Commission in southern Iraq's Basra Province has conferred with the British Consul in Basra, Richard Wood, on Wednesday on means for presenting facilities for British companies to invest in the Province. (Aswat Al-Iraq)
- Iraq will award contracts worth \$2.2bln in early May to build four gas fired power plants, according to Electricity Minister Raad Shallal. (Iraq Directory)
- Britain discussed plans to exploit Iraq's oil reserves with some of the world's biggest oil companies five months before it joined the United States in invading the country, the Independent newspaper said on Tuesday. (Noozz)
- Iraq's annual inflation rate is expected to remain within single digits in 2011 helped by a national food ration programme which is absorbing some of the increases in food prices, a central bank adviser said on Sunday. (Iraq Directory)

ISX -Company Announcements

- Gulf Commercial Bank (BGUC) will hold Annual General Assembly Meeting (AGM) meeting on May 10, 2011 to discuss the annual financial report for the fiscal year ended December 31, 2010, the cash dividend distribution ratio and the capital increase through 75% (ID43.01bln) bonus and rights issues to reach ID100bln paid-in capital according to the Iraqi Central Bank instructions. ISX will suspend trading of BGUC shares starting May 3, 2011.
- Mosul Bank (BMFI) will hold AGM on May 22, 2011 to discuss the annual financial report for the fiscal year ended December 31, 2010, the cash dividend distribution ratio, the capital increase through bonus and rights issues and the incorporation between Mosul Bank (BMFI) and Union Bank of Iraq (BUOI). ISX will suspend the trading of BMFI shares starting May 15, 2011.
- Baghdad for Packing Materials (IBPM) will hold GA on April 27, 2011 to discuss the capital increase through 200% rights issue. ISX suspended trading of IBPM shares starting April 20, 2011.
- Al-Ayaam Financial Investment (VAYF) resumed trading on April 19th, 2011. VAYF shares wasn't trading since April 9, 2011 due to General Assembly (GA).
