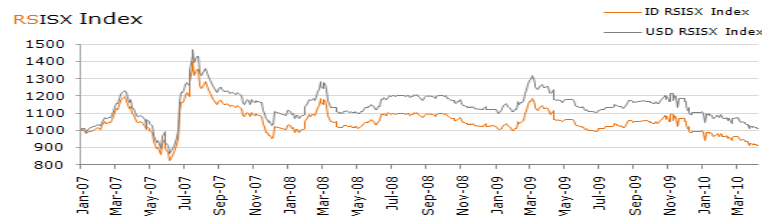

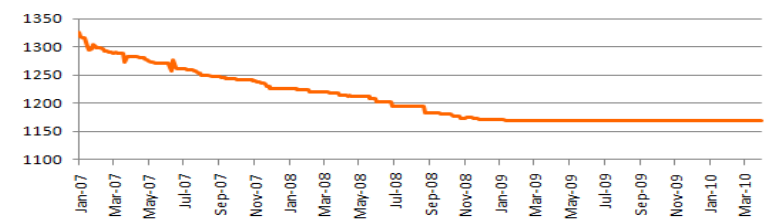
By the end of the week, 44 companies were able to trade in this session, and 14 companies were unable to do so mainly due to their General Assembly Meeting.

The dinar remained stable for the week, trading at 1170 to the dollar. Volumes for the week reached ID5.1 bln (US\$4.4 mn), and the numbers of shares traded reached 2.7 bln, with the banking sector experiencing the highest volume and turnover.

Foreigners executed total 58 transactions this week. They executed 46 buying transactions amounted at ID83.7 mn (US\$71.5 ths) and 12 selling transactions amounted at ID14.6 mn (US\$12.4 ths). The total number of traded shares was 41.1 mn, and the total trading volume was ID98.2 mn (US\$84.0 ths).

## News From Iraq

### Politics

- Iraqi President Jalal Talabani discussed on Tuesday with Secretary General of the Communist Party, the ongoing talks to form a national partnership government.
- The State of Law Alliance and Iraqi National Alliance (INA) are approaching an advanced stage to exclusively set the rules of how to select Iraq's upcoming prime minister (PM) from within the two alliances. . Ali al-Adeeb, a high-ranking member of the Dawlat al-Qanoon and Dawa Party, said on Wednesday.
- Iraqi President Jalal Talabani on Wednesday called on neighboring countries not to interfere in Iraq's affairs and to respect Iraq's sovereignty.
- Speaker of Kurdistan region Kamal Karkouki discussed with the ambassador of the Russian Federation to Iraq the latest developments in Iraq and ways of boosting bilateral relations, according to a parliament's statement.
- President of Kurdistan region Massoud Barzani discussed with Lebanese president and speaker of the parliament ways of boosting bilateral ties in various domains.
- Iraqi Foreign Minister Hosheyar Zebari described the visit of Iraqi President Jalal Talabani to Saudi Arabia as successful.

### Economics

- The Council of Ministers authorized Finance Minister Baqer al-Zubaidi to discuss investing the rest of the Japanese loan (around US\$220 mn) with the Japanese ambassador.
- The deputy head of the Basra council, Ahmed al-Sulaity, discussed with the Iranian consul future plans for cooperation in the power and water field.
- Some 250 Turkish businessmen will visit the Iraqi Kurdistan region in September to probe investment opportunities.
- An Iraqi investor got a license to establish a residential compound in southern Diwaniya at a cost of US\$21.24 mn within 36 months.
- The Council of Ministers agreed on Tuesday on the proposal presented by the Oil Ministry to establish the Central Oil Company with a capital of ID100 bln (US\$85.5 mn).
- The National Investment Commission has approved two investment projects with a total cost of US\$485 mn.

### ISX - Recent Company Announcements

- Al-Mansour Pharmaceuticals Industries' (IMAP) General Assembly Meeting will be held on May 8th, 2010 to discuss annual accounting report, the change in company name of "Al-Mansour Pharmaceuticals Industries" to "Al-Mansour for Pharmaceuticals, Medical Accessories, Cosmetic and Sterile Water Industries", the dividend distribution ratio and capital increase through bonus issue. IMAP shares will stop trading on April 24th, 2010.
- Al-Kheir Financial Investment's (VKHF) General Assembly Meeting will be held on April 29th, 2010 to discuss the election of new board members.
- Nationality Household Furniture Industry (IHFI) announced that subscription for new rights issue started on April 13th, 2010 in Mousel Bank.
